2- That I do not show symptoms compatible with Coronavirus SARS-COV-2 (fever greater than or equal to 37.5 degrees, cough, general malaise, shortness of breath, loss of taste, headache, fatigue, sore throat, muscle aches, vomiting, diarrhea) or any other typical symptoms of infections.

3- That I have not tested positive or had close contact with any person or persons with possible or confirmed symptoms of COVID-19 in the 14 days immediately prior to the date of signing this document.

4- That I have read the safety protocols and the informative measures and of prevention of hygiene and security of the COVID-19 arranged by the organizer of the competition and I accept them to fulfill of responsible way, in his totality, with the guidelines of conduct and behavior that are established there, accepting that the Person in charge of Hygiene of the event can agree motu own my exclusion of the competition and of the installation or bounded zone of the sport space in case of breach. the.

5- That I am aware and accept that non-compliance with the rules of COVID-19 especially the non-declaration of having given a positive or not having declared the fact of having had a close relationship with people with symptoms implies a very serious violation of the disciplinary code that may result in a sanction of exclusion from the competition and loss of sports license for the entire season.

6- That I undertake to inform the club and the Federation (before any match) of any symptoms that are compatible with COVID-19, the fact of having tested positive or the existence of any presumed or confirmed case of COVID- 19 in the family or close environment and I undertake to keep the club officials informed of the evolution of the same.

This information will be treated confidentially and for the sole purpose of being able to take the necessary measures to prevent the spread and spread of viruses. By completing this document, the undersigned gives express consent for the FCEH to process this data from a strictly medical and prevention point of view.

At the same time and with the signing of this document it is declared to know the specific measures of protection and hygiene established in the Protocol of the CSD, RFEDI and FCEH and that the norms are of obligatory fulfillment for the participants in the official sport competitions RFEDI and / or FCEH and for all the clubs affiliated to the Federation that participate in the same.
